- Do you have a certified competent person on each job site when excavating over four feet?
- OSHA requires that you have a competent person on site while workers are present, and the excavation is open. Required by the current OSHA Standard, 29 CFR 1926.650 Subpart P.
- Competent Person Training in Excavation is required by the current OSHA Standards, 29 CFR 1926.650 Sub Part P.
- Scope: This sub-part applies to all open excavations made in the earth's surface. Excavations are defined to include trenches.

This class is certified by the Georgia Construction Industry Licensing Board and meets part of the 12-hour requirement for the Utility Manager License and Utility Foreman Certification.
