- Are your employees in manholes, excavations, foundations, underground vaults, sewer pipelines, or any location where confined spaces can exist and cause hazards?
- If so, you are required by OSHA to understand the hazards involved in confined space and train your employees on the hazards associated with confined space entry.
- OSHA requires that you have a competent person in confined space entry and a monitor on each jobsite while performing confined space entry work.
- This course is designed to train owners, project managers, foremen, and safety personnel on the hazards associated with confined space entry. It covers the techniques, methods, and equipment used to ensure a safe entry.

This class is certified by the Georgia Construction Industry Licensing Board and meets part of the 12-hour requirement for the Utility Manager License and Utility Foreman Certification.
