- This is an 8-hour Locating and Marking Underground Pipeline Facilities Course designed for beginners or advanced users. At least one person on a crew needs to be able to understand how to locate and verify underground facilities.
- Federal regulations require that you must be qualified to locate underground gas facilities. Whether you are locating for the facility owner as a contractor or locating to verify it is safe to dig, at some point excavators will have a need to do so.
- This 8-hour course will discuss basic theory of locating through Conductive and Inductive methods. There will be hands on training to ensure that each participant leaves with the knowledge to apply this practice in the field.
- A Certificate of Completion will be given to all attendees who complete the class. If you take the class for GAS OQ, then further information will be provided by the instructor for continuing certification.
